



Thank you for your interest in becoming partner of Give Kids The World (GKTW), a 70-acre, non-profit resort in Central Florida that creates magical memories for children with life-threatening illnesses and their families. In order to grant these Central Florida dream vacations, each child is sponsored in their local communities by one of over 250 Wish-Granting Organizations (WGO) and children's hospitals that partner with GKTW. Children are between the ages of 3 and 18 years old and have been pre-qualified by their WGO by receiving a diagnosis of their illness from a licensed physician.

**The WGO provides airfare and spending money for each family's visit to Central Florida and GKTW. GKTW will charge your foundation a support fee per Wish child of \$750 or \$1,000. This fee allows us to provide the following amenities for six days and six nights for all domestic Wish families or seven days and seven nights for international Wish families.**

- Tickets to SeaWorld Orlando, Universal Orlando, Walt Disney World and various other smaller parks are offered to our families at no cost by our many gracious corporate sponsors
- Lodging in one of our fully wheelchair accessible two bedroom, two bathroom Villas complete with a full kitchen stocked with snacks when the families arrive, a front and backyard, and a washer and dryer in their Villa
- Free reign over our whimsical, fairy tale resort which includes two pools, a water garden play area, a magical castle with a wheelchair accessible carousel, a playground that is a life-size version of Candyland, a dinosaur-themed miniature golf course and much, much more
- Complimentary meals at one of our two on-site themed restaurants as well as unlimited pizza delivered right to the family's Villa and unlimited ice cream in our whimsical Ice Cream Palace
- Nightly Entertainment including our Winter Wonderland celebration, Pirates and Princess party and Village Idol
- Daily gifts themed with our entertainment for that night left in the family's Villa
- For the \$1,000 fee, your family will receive a rental vehicle at their disposal for their entire vacation.
- For the \$750 fee, we offer scheduled Mears transportation to and from the airport and main parks.

**If you would like to become a WGO for Give Kids The World we require the following documentation from your organization:**

- Your current Bylaws, Form 990 (or other financial statement)
- Proof of your 501C3 (or other charitable organization certificate) stating your organization is a nonprofit
- A completed WGO registration form faxed or emailed to us

Upon receipt of these materials and approval of your foundation, we will provide you with an electronic manual which outlines our policies and procedures.
